### Minutes of October 2024 meeting - vote / approve

Corrections: a few minor ones made just prior to meeting, which do not affect the substance of minutes. <u>Motion to approve</u>: Julia, Second Margie. Vote: Motion <u>passes.</u>

### Finances - Treasurer Report (Debbie Hall)

- Balance sheet: Checking \$224,574.93, Savings \$500.37, Investments 142,823.38 = \$367,898.68 as of 10/31/24.
- YTD financials reviewed. RDs should submit expenses promptly due to upcoming holidays...

# **Discussion Topics**

- 2025 Budget Race Budgets were submitted. With current dividend income and conservative race budgets, income exceeds expenses. Reduced expenses on storage and professional fees for graphic design/newsletters. Races may do better in the recovery year, and reasonable expenses (such as advertising to promote low registration) is acceptable. Balanced budget is expected, unless the nonprofit is rebuilding reserves or plans a capital expenditure. Tracy has annotated the budget with suggestions to balance income/expenses. Margie moves that we accept these changes and approve the budget as amended. Mark seconds. Vote: Motion carries.
- Membership Report (Margie):
  - Members year to date: 772 (last year 735).

Memberships year-to-date: 554 (last year 735)

Family memberships: 112
 Individual memberships: 431
 Student memberships: 11

- Award Nominations for 2025 Awards Banquet Presented and discussed, no vote needed.
  Several awards are named after historical club members, such as the Cathy Weicamp award.
  Also Volunteer award (Juliana M), Volunteer of the year (Judy W), Club appreciation (Foot Traffic for hosting runs), and Lifetime memberships (for two very deserving members).

- Policies & Procedures Manual discussion Policies & Procedures Draft 11-8-2024
  - Logo policy for races. Agreed that races may have their own logo. Process for designing a logo reviewed. Is this an RD decision? Board Approval? A committee? Daniel designed a graphic for Solstice bandana last year, but it would not work on other merchandise. Deb reports that the Logo/Rebranding workshop at RRCA conference suggested: form a committee to get multiple points of view, hire a professional designer, ensure the logo represents the club/event; leaving decisions to a sole RD could be problematic. Charissa agrees multiple persons should review to avoid unintentional problems. Mark T. mentions (in chat) using graphic designer and checking for copyright infringement. Mark B. has used Ashworth and Leslie Jordan designers. Charissa can submit info with specs that may be needed for logos, which Tracy can add to P&P.
  - Nonbinary/Transgender Entrants Policy in P&P Draft (Deb B.) this was duplicated from Hagg Mudd and previous version in ORRC RD Manual. RRCA does encourage inclusive practices such as nonbinary registration option. USATF/IOC rules are very restrictive and tend to be reserved for elite competitions. After doing research on best practices per RRCA, the language should be updated further, including the title of the policy. Deb will email a draft to the board, which is now in the ORRC RD manual. It contains some explanation, resources, sample language, and suggestions for creating an inclusive event.
  - ORRC RD Manual vs. External RD Workshop Manual very different content in some cases, should they be combined? Mark worked on the ORRC RD Manual and feels some of this info is helpful for new RDs. This can be tabled for now, with further discussion between Tracy, Mark and possibly Deb B.
  - Recognizing that this is a "moving target" and working document, should we approve this current P&P draft? Daniel Brewer so moves, Margie seconds, <u>Vote:</u> motion passes.
- Shamrock Expo confirmed we will do this again in 2025
- RRCA Convention 2025 (who should go)? Sending people is an investment for the club.
  Daniel will pay his own way and is hoping to be a state rep. Interested: Carrie, Kim, Suzie,
  Mark Takizawa (new RD and board member). Charissa interested but also wants to promote

RRCA benefits to ORRC members. Tracy could mention RRCA convention in e-newsletter and offer scholarships for club members.
